## A Message from the Board Chair and Executive Director

The 2025–2026 fiscal year was one of great progress for the South Huron Hospital Foundation, reflecting the strength of our community, the generosity of our donors, and our commitment to building a sustainable future for local healthcare.

Thanks to the generosity of our donors and community, the Foundation generated \$1.38 million in revenue this year, including more than \$1.1 million from donations and fundraising activities and over \$271,000 in investment income. Prudent financial management led to an annual surplus of \$426,004, bringing our accumulated surplus to \$4.35 million. With \$1.7 million invested in a recent land acquisition, we are well positioned to support future healthcare investments in South Huron.

These strong financial results do more than demonstrate success— they provide the Foundation with the ability to respond to healthcare needs today while preparing for the opportunities of tomorrow.

As healthcare continues to evolve, we remain committed to being an agile and forward-thinking organization. Rural healthcare is not one-size-fits-all, and neither is the work of your Foundation. We continually adapt to the changing needs of our community, and collaborate closely with our healthcare delivery partners, Huron Health System.

### Patient Beds \$36,020

Two new patient beds were acquired to replace outdated equipment, providing improved safety features, greater comfort, and better support for patient well-being.



### GlideScope \$17,729

A new GlideScope was acquired for the Emergency Department, enhancing patient safety and supporting rapid, life-saving airway management during medical emergencies.



### Lab Refrigerator and Freezer \$19,000

The purchase of a new laboratory-grade refrigerator and freezer strengthens our laboratory's ability to safely store blood products and patient specimens. Supporting over 88,000 laboratory procedures annually, this equipment plays a vital role in delivering accurate, reliable diagnostic services for our community.

# YOUR IMPACT



## Pharmacy Project- \$431,000

One of the Foundation's most significant investments this year was the completion of the \$431,000 Pharmacy Project, a transformative initiative that has strengthened medication management, patient safety, and pharmacy operations at South Huron Hospital.

The project included the purchase and installation of two new Pyxis automated medication dispensing systems, fully integrated with the hospital's Oracle electronic patient charting system. This integration ensures patient medication orders and chart information are communicated directly and accurately between clinical staff and the Pharmacy, giving healthcare providers immediate access to critical medication information at the point of care. The enhanced technology promotes accurate dispensing, appropriate dosing, improved medication security, and greater patient safety.

The project also included the relocation and expansion of the Pharmacy department, creating a more functional workspace designed to support efficient workflows and future growth. The expanded pharmacy allows staff to better manage increasing medication volumes and service demands while improving day-to-day operations.

Completed in less than a year, this project has delivered a dramatic improvement in Pharmacy operations, providing our healthcare team with the tools, technology, and space needed to deliver safe, efficient, and high-quality patient care for years to come.

# What's Next? 2026 and Beyond...

From IV Pumps to a proposed CT Scanner—we're preparing for bold impact.

The South Huron Hospital Foundation **has committed to funding \$517,500** in priority equipment and facility improvements during 2026–2027. These investments include several

important enhancements to the Emergency Department, such as new examination lights, a ceiling lift, two patient stretchers, and the creation of a patient safe room designed to support individuals experiencing mental health emergencies with care, compassion, dignity, and safety. The list also includes new IV infusion pumps for every patient room at a cost of \$142,000, a blood gas analyzer, a bladder scanner, and many other pieces of essential equipment that help our healthcare teams provide exceptional care close to home.

In addition to these immediate priorities, the Foundation has committed **\$4.1 million toward a future CT Scanner Project, pending final approvals**. The addition of a CT scanner would be transformative for South Huron Hospital, significantly enhancing diagnostic capabilities, improving patient access to advanced imaging, and strengthening emergency care services for our community.

We would also be remiss if we did not acknowledge **the Foundation's acquisition of land adjacent to the hospital**. While the original vision was to develop a new medical centre that would support physician recruitment and retention, expand healthcare services, and create additional space for the future of healthcare delivery in our community, that project is currently paused while a comprehensive feasibility review is completed. In the meantime, the acquisition of this strategically important property ensures that South Huron Hospital is well-positioned for future growth and development, whatever form that may take.
